



**Kokanee Krew Outfitters LLC Acknowledgment of Risk Form**

The undersigned recognizes the element of risk in any adventure, sport, or activity associated with the outdoors. The undersigned is fully aware of the risks inherent in fishing and boating activities conducted on National Forest System (NFS) lands, including but not limited to, lightning storms and other adverse weather conditions, domestic or wild animals, fires, travel either on foot or in a vehicle in unfamiliar terrain or over fences and other structures, artificial and natural obstructions, and unimproved roads as well as traveling in company owned vehicles. The undersigned understands that the possible consequences of participating in this activity include personal injury, death, and damage or loss of personal property.

The undersigned has the necessary skills and ability to participate in fishing and boat activities conducted by Kokanee Krew Outfitters LLC on NFS lands and assumes full responsibility for bodily injury, death, and loss of personal property as a result of the undersigned's negligence in participating in fishing and boat activities conducted by Kokanee Krew Outfitters LLC on NFS lands, except to the extent that the bodily injury, death, or loss of personal property may be due to the negligence of Kokanee Krew Outfitters LLC.

The undersigned also agrees to abide by the rules or instructions given to the undersigned either verbally or in writing by Kokanee Krew Outfitters LLC. The undersigned further understands that Kokanee Krew Outfitters LLC reserves the right to refuse to allow any person to participate in this activity who is judged to be incapable of meeting the rigors and requirements of participation.

The undersigned has read, understood, and accepted the terms and conditions in this agreement. The undersigned's participation in fishing and boat activities conducted by Kokanee Krew Outfitters LLC on NFS lands is purely voluntary, and the undersigned elects to participate despite the risks.

If the undersigned files a lawsuit against Kokanee Krew Outfitters LLC in connection with fishing and boat activities conducted by Kokanee Krew Outfitters LLC on NFS lands, the undersigned agrees to file solely in the State/Commonwealth of Utah and agrees that the substantive law of that state shall apply in that lawsuit without regard to the conflict of laws rules of that state. The undersigned agrees that if a portion of this agreement is found to be unenforceable, the remaining portions shall remain in effect.

I further agree to release the State of Utah, the United States Bureau of Reclamation, and the Provo River Water Users Association, their agencies, departments, officers, employees, agents and all sponsors, officials and staff or volunteers from any and all liability, claims, demands, breach of warranty, negligence, actions, and causes of actions whatsoever for any loss, claim, damage, injury, illness, attorney's fees or harm of any kind or nature to me arising out of my participation with Kokanee Krew Outfitters LLC. This release extends to any claim made by my family, estate, heirs, or assigns arising from or in any way connected with the aforementioned activities."
